#### **Persons Who May Not Marry:**

- Blood relatives – nearer of kin than second cousins, except when the female is 55 years of age or older.
- Persons declared incompetent by the Court.
- A person under the age of 16.
- A person who is divorced is prohibited from marrying until 6 months after the date the divorce was granted, as directed by WI §765.03(2).

#### **Persons Who May Marry:**

Every person who has attained the age of 18 years is of age. If a person is 16 or 17 years of age, a license may be issued with the written consent of the person's parent(s), guardian or custodian. Parents, guardian or custodian consent forms must be executed at the time of application before the County Clerk or certified in writing and verified before a Notary Public.

**Waiting Period:** Upon making application, a 5-day waiting period is required by law. This is exclusive of the day of application. The license will be issued on the sixth day and is good for 30 days from the date of issue.

**When should you apply:** No more than 35 days prior to the marriage date – and no less than 7 days before to the marriage date.

**Witnesses:** Two adult witnesses (18 years of age or older) are required for the ceremony in addition to the person officiating.

## **MARRIAGE APPLICATION REQUIREMENTS:**

**All requirements apply to BOTH applicants.**

- **Applicants must apply in person and together.**
- **Valid Picture ID: BOTH** must show at the time of the application a **Current un-expired State ID, Driver's License or Resident Alien ID.**
- **Proof of Residency: Both applicants must show proof of where they reside.** Current un-expired Driver's License, State ID, Resident Alien ID with current address or a **current utility bill or government mail** dated within 30-60 days ago, showing individual name and street address.

**Residents** of the State must apply in the County in which either is a resident. They may be married in any County of the State.

**Non-Residents** of the State must apply in the County in which the marriage ceremony is to be performed. Proof of out-of-state residence must also be submitted.

- **Certified Birth Certificates:** Required from all applicants, regardless of age. Certified Birth Certificates must not be torn, taped or have holes. Certified copies can be obtained from the County or State in which one was born. Photocopies, Registration of Birth Record or Hospital Souvenir records will not be accepted. Certified Birth Certificates in a foreign language must be translated into English by a third party and notarized. Translation must be done from the certified copy. Both the Certified Birth Certificate and notarized translation must be presented at the time of the application.
- **Social Security Numbers Are Required.**
- **Divorce Papers/or Certified Death Certificate:** If either of the applicants have been previously married, they must provide a copy of the Divorce Judgment with the court file stamp and judge's signature, Annulment papers or a Certified Death Certificate from their last marriage. If the marriage ended in divorce, it must be final for a minimum of six months whether the divorce was granted in Wisconsin or elsewhere.
- **Officiant:** Name, address, phone number and email address of the person performing your wedding ceremony.
- **Courthouse Weddings: *Courthouse Weddings need to be scheduled prior to applying for the marriage license.*** To schedule call the Office of the Clerk of Circuit Court, 262-653-2465.

#### 1. Submit Evidence of U.S. Citizenship & Black/White Photocopy

*(Certified copy must be submitted with application and will be returned to you by the U.S. Dept. of State)*

Previously Issued, undamaged U.S. Passport

Certified Birth Certificate issued by the city, county or state\*, must list parent's full names, no matter what age of applicant – must be in acceptable condition, it cannot be torn, taped or have holes

Consular Report of Birth Abroad or Certification of Birth

Naturalization Certificate – must be the original

Certificate of Citizenship – must be the original

**\*A Certified Birth Certificate** has a registrar's raised, embossed, impressed or multicolored seal, registrar's signature, and the date the certificate was filed with the registrar's office, which must be within 1 year of the birth. Please note, some short (abstract) versions of birth certificates may not be acceptable for passport purposes.

2. A **current** valid State issued driver's license OR a State ID with additional forms of photo identification. **\*\* Out of State ID's** also require additional identification documentation. **\*\*** (see page 106)

**3. One COLOR Passport Photo;** full front view with a plain white background, normal street attire, no hats or headgear. **NO GLASSES,** camouflage or military attire. **Do not attach photos to the application.**

**PASSPORT PHOTOS may be taken at the Clerk's Office for \$10**

**APPLICANTS UNDER THE AGE OF 16**

If application is for a **CHILD UNDER 16 YEARS OF AGE, PARENTS LISTED ON THE CERTIFIED BIRTH CERTIFICATE MUST BOTH APPEAR** at the time of the application, with their driver's license or state ID, and the child must also be present. Even if the child has had a previous passport, you also need to submit a "Certified Birth Certificate" to show the child's relationship to the parents. Whether form DS-3053 is used, or the same information is provided on other paper, the Statement of Consent by non-applying parents for children UNDER THE AGE OF 16 **MUST BE NOTARIZED and MUST ALSO INCLUDE A COPY OF THE FRONT & BACK OF THE NON-APPLYING PARENT'S ID USED FOR THE NOTARY.**

**\*\*SPECIAL NOTE REGARDING MINORS\*\*** **establishing child/parent relationship.** If the mother's current name on her identification does not match the child's name, proof of the name change needs to be submitted with the application and/or minor consent form. Examples would be a Certified Copy of the Marriage Certificate or a Certified Copy of the Court Document.

### WHEN ADDITIONAL IDENTIFICATION IS REQUIRED

\*\*When additional identification is required to establish identity these are some personal documents that may be considered: Professional ID, Government ID (Federal, State, Municipal), Student ID (school or college), Driver's License, Military discharge, Selective Service Registration Card and/or Classification card, DD-214, Official Military ID, Union membership card, Professional license (pilot, nurse, beautician, x-ray technician, etc.), Business Card, Medicare Card, Welfare Card, Marriage certificate, Divorce decree, School or College diploma and or transcript, Credit card (*if a credit card is presented as the second ID, a photocopy will not be submitted, document type, full name and issuance date will be notated on the whitespace of the photocopy of the primary identification*), Insurance papers, Expired passport, Baptismal certificate, Voter registration card, Vehicle registration and/or title, Birth Certificates of children born to you. Copies will be made and sent with application for consideration.
